Decision no.143/2018
of the Warsaw University of Technology Rector
of 28 August 2018

on the tuition fees payable by foreigners undertaking study and other forms of education at the
Warsaw University of Technology

Pursuant to § 11 of the regulation of the Minister of Science and Higher Education of 5 June 2018 on undertaking and pursuing study and trainings by foreigners and their participation in research and development work (Journal of Acts of 2018, item 1125) it is decided as follows:

§ 1

1. The following semester tuition fees (in Euro) payable by foreigners pursuing degree programmes as fee-paying students are hereby determined:

2. The fees determined in point 1: the fees for first-cycle degree programmes column [3] and the fees for second-cycle degree programmes column [4], hereinafter referred to as the nominal fee for the degree programme in a given semester, marked with the symbol k_n , apply to the nominal number of ECTS foreseen in a given semester in the study programme and the nominal number of ECTS, hereinafter referred to as $nECTS$, may amount to:
 - 1) basically, 30 ECTS,
 - 2) may be different than 30 ECTS in special cases.
3. Subject to points 4-6, the semester fee k_s for the first- or second-cycle study programme of a given student in a given semester is determined with the following formula:

$$k_s = \frac{k_n}{n ECTS} \cdot l ECTS$$

where:

| k_n – | nominal fee for the study in a given semester, |
| $n ECTS$ – | nominal number of ECTS points in a given semester determined in the study programme, |
| $l ECTS$ – | total number of ECTS points for all courses completed by the student from the study programme for a given semester (i.e., in the semester he/she is registered on), from previous and subsequent semesters, and also make-up courses determined by the Dean of the Faculty, both those completed for the first time and those retaken; |

4. In justified situations, the Dean may take the decision to make the formula laid down in point 3 more detailed.
5. The fees for consultations on the diploma thesis for students retaking the last semesters of degree programmes are:
 - 1) in first-cycle study PLN 220 (lump sum);
 - 2) in second-cycle study PLN 390 (lump sum).

6. The fee for consultations of mid-term papers in first- and second-cycle study, if retaken, is a lump sum of PLN 100.

§ 2

1. In economically justified situations, especially when there are greater numbers of foreign candidates to degree programmes, the Dean of the Faculty, Director of the College, Director of the Business School, as applicable, may apply to the Rector to determine a lower semester fee (in Euro) than the amount specified in § 1 section 1 in a given academic year, for candidates admitted to study in a given academic year.
2. A non-returnable fee for admissions proceedings to first- and second-cycle degree programmes, and doctoral degree programmes is EUR 200.

§ 3

Decision no. 185/2015 of the WUT Rector of 10 December 2015 on the tuition fees payable by foreigners who undertake degree programmes and other forms of education at the Warsaw University of Technology expires.

§ 4

The decision enters into force upon its signing.
